

UC Davis Regents' Bar Loan

Application Instructions

Regents bar funds are limited. Please read the following information and instructions carefully. You may receive assistance from only one Bar Loan source.

- ◆ Only current need-based financial aid recipients will be considered for a Regents Bar Loan.
- ◆ Applicants must graduate in **May 2009** and be registered for the **July 2009** Bar Exam.
- ◆ **The maximum loan available for 2009 will be \$4,000 per student.**
- ◆ Graduating students are required to complete on-line exit loan counseling for both federal and private loans. **If you do not complete exit loan counseling before you graduate, your Regents Bar Loan will immediately become due and payable.**
- ◆ Interest at the rate of **eight (8) percent** will be charged **from June 1, 2009.**
- ◆ Payments can extend over a maximum of three years; however, a **\$50 minimum monthly payment will be required.**
- ◆ Repayment must begin no later than **January 1, 2010.** Early repayment plans are available and encouraged for those who are able. Preference should be indicated on the application.
- ◆ **The application must be completed thoroughly.** Omissions or failure to accurately and honestly report resources you have (or may expect to have) available will result in automatic denial.
- ◆ **Three addresses** must be provided: Your permanent address **and** the names and addresses of two people who will always know your whereabouts, one of whom must be a parent or other relative and **neither** of whom can be a student.
- ◆ The Promissory Note will be provided for your signature upon approval of the loan.
- ◆ Deferment may be available for those who are unemployed but actively seeking employment, subject to consultation and approval of the Law School Financial Aid Office and the Supervisor of Student Accounting.

Prompt repayment is essential if we are to assist future graduates.
