The need for urgent action is heightened by three recent events:

- The U.S. Supreme Court ruling in Plata, which requires the State to significantly reduce the prison population.
- Assembly Bill 109, which mandates realignment of responsibility and resources for low-level offenders to local government.
- A *Los Angeles Times* survey that found 60 percent of voters support 3-Strike sentence reductions for property offenses.
