Join a Fellowship Program

- Work as a corps on designated priority issue
- Interviewed and selected by host organization
- Rolling and seasonal deadlines pending availability
- Apply after graduation and bar exam for immediate hire

Design-Your-Own Fellowship

- Project-based
- Work with your prospective host organization to design a project and submit an application as a rising 3L (application closes September 2024)
- Interviews are conducted by Equal Justice Works staff and selected sponsors

/ Fellowship Components: Candidate

Class of 2025 Eligibility

- Graduate of member law school by September 2025 with a JD or LLM
- No previous full-time, permanent public interest attorney position
- No previous participation in other major Fellowship programs (Skadden, Echoing Green, etc.)
- No transcript or GPA/class rank required

Keys to Success

Demonstrated commitment to public interest



/ Fellowship Components: Project

Eligibility

- Under-served people and/or issues in our legal system
- Direct services, advocacy, education, litigation, or some combination
- Innovative project
- Not a public defender position or focused on international law

Keys to Success

 Not a staff attorney position, built-in sustainability, ambitious but feasible

/ Fellowship Components: Host Organization

Eligibility

- Non-profit organization with legal staff
- Capable of providing benefits, health insurance, office space or remote work option
- Able to support and supervise new attorneys
- Based in the United States or territories

Keys to Success

 Supervisor has experience in the project area, project aligns with strategic vision and mission, prior relationship a plus, look far and wide for best fit



/ Fellowship Components: Sponsors

Fellowship sponsors may express issue area or geographic preferences for the Fellowship projects they will consider for funding.

- Law firms, corporations, foundations, bar associations, individuals
- Engaged in the selection process and throughout the two years of the Fellowship
- See our website for updates on sponsor interest in particular geographic and issue areas



/ Design-Your-Own Fellowship Benefits

- Hands-on experience in chosen issue area
- Networking opportunities with other Fellows and alumni in the field
- Salaries are set by the host organization, commensurate with the starting staff attorney salary for that region or city
- Health care coverage and other fringe benefits
- Equal Justice Works' Loan Repayment Assistance Program
- Leadership Development Training in October
- Participation in Alumni Network



/ Writing a Competitive Application

- Different than a standard job application or grant proposal
- Focus on fit: Candidate's unique ability to bring the right project, at the right time, with the right organization
- Demonstrate your ability to blend data, personal stories, and client narratives to highlight your project's anticipated impact on your identified community
- Key sections: Statement of Need, Goals, Timeline, Personal Statement, and Sponsor Involvement



/ Most Common Application Mistakes

- Neglecting the "Pro Bono Opportunities" section this section is particularly important for potential sponsors
- Disjointed personal statement; summarizing your resume in your personal statement
- Not including information on the legal/service provider landscape and/or your community partners
- Overambitious project design
- Generic and/or vague one-sentence project description
- Typos, spelling or grammatical errors, lack of clarity use a review team



/ What Should I Do Now?

1Ls should start:


- Thinking about the type of Fellowship project you're interested in, identifying internships with organizations that do that type of work, and building relationships
- Investing your time in gaining public interest experience

2Ls and 3Ls that are clerking/taking a gap-Fellowship should start:

- Approaching potential host organizations
- Asking professors and supervisors for letters of recommendation
- Fine-tuning your resume and outlining your personal statement

/ 2L Timeline

- April 2024: Applications Open
- September 2024: Applications due
- October 2024: Alumni review and score applications
- November 2024 March 2025: Candidates are interviewed by prospective Sponsors
- November 2025 March 2025: Candidates are selected on a rolling basis
- May 2025: Selection process closes, Class of 2024 Fellows is announced
- September 2025: Fellows begin work at host organization




/ 1L Timeline

- April 2025: Applications Open

- November 2025 March 2026: Candidates are selected on a rolling basis
- May 2026: Selection process closes, Class of 2025 Fellows is announced

/ Join a Fellowship Program

1. Learn About Our Programs

Equal Justice Works offers Fellowship programs that address a range of legal issues. Following graduation, explore our current programs to see which one aligns with your passions and which are accepting applications

2. Select a Program

If a program is accepting applications, view the list of organizations that are part of the program and have an open Fellowship position.

3. Apply Directly to the Host Organization

Candidates submit their applications directly to participating host organizations. Host organizations conduct interviews and select their Fellow.



/ Current Fellowship Programs

Disaster Resilience Program

Equal Provide comprehensive legal services before, during, and after a disaster.

Housing Justice Program

Provide advice, referrals, and full representation for tenants, in support of safe, fair, and affordable housing.

Crime Victims Advocacy Program

Increase access to legal aid for survivors of crime.

/ Fellowship Program Benefits

- Health care coverage and other fringe benefits (vary depending on the program)
- Leadership Development Training in October
