**Visiting Student Agreement Purpose and Instructions**

The purpose of this agreement is to enable students from the UC Davis School of Law or **Home School** to receive financial aid for study at another ABA approved law school or **Host School**. The Host School will notify UC Davis School of Law if the student changes his/her enrollment status or withdraws from the study away program. UC Davis School of Law is responsible for the procedures for calculating awards, disbursing aid, monitoring satisfactory progress and other student eligibility requirements, keeping records, and distributing FSA refunds.

The Host School must complete and sign the Visiting Student Agreement (VSA) and return the form to the Home School. The Home School will use the Host School budget to determine the amount of the financial aid award.

**Financial aid for Study Away**

Law students who are U.S. Citizens or Eligible Non-Citizens can apply for financial aid by completing the Free Application for Federal Student Aid (FAFSA). The UC Davis School of Law Financial Aid Office will use the information you provide on the FAFSA to determine your financial aid eligibility for study away.

**Aid Disbursement Information**

Aid is scheduled to disburse ten (10) days before the start of each term at UC Davis School of Law. You must submit your completed Visiting Student Agreement (VSA) and proof of registration at the host school to the Law Financial Aid Office before the start of the term or your financial aid disbursement may be delayed.

**Direct Deposit**

It is the policy of the UC Davis School of Law Financial Aid Office to require students who study away to sign up for Direct Deposit service. Sign-up for this service online at <http://directdeposit.ucdavis.edu>, using your UCD Login ID and Kerberos password.

**Satisfactory Academic Progress**

Students who receive financial aid are expected to maintain satisfactory academic progress as set forth in the UC Davis School of Law Academic Regulations to remain eligible for financial aid. In addition, students who withdraw, drop out, or drop below half-time enrollment may be required to repay financial aid.
